Terms and Conditions

1. This organization is providing spay/neuter services at a greatly reduced rate under the Feline Fix program. The following mandatory services are covered:
 - a) Anesthesia for the surgery
 - b) Sterilization surgery
 - c) Microchip
 - d) Ear Notch
2. This Certificate does not include medication or services required for the treatment of any post-surgical complications arising later than 24 hours after surgery.
3. Free-Roaming cat caregivers are responsible for making a surgery appointment and complying with all instructions given by the veterinarian before and after surgery.
4. Free-Roaming cat caregivers must complete all of the information required on this Certificate at the provider's office in order to qualify for Feline Fix services.
5. Veterinarians may decide that animals may be unhealthy and not medically fit for surgery.
6. Caregivers must be 18 years of age or older.
